## Compliments Card Fundraising Program Agreement

This agreement is between Compliments International, llc, hereinafter referred to as "Compliments" and \_\_\_\_\_, hereinafter referred to as the "Organization".

The Compliments Card is a 1 year membership card entitling the holder to receive unlimited discounts at a variety of establishments, including, but not limited to, restaurants, sporting venues, spas, health clubs, retail establishments, entertainment venues, services and professions. This agreement permits the Organization to sell the Compliments Card and to receive 25% of the retail sales price of each card purchased towards the Organization's fundraising efforts. Each time the card is renewed by the customer after one year, the Organization will receive 50% of the original commission.

This contract is legal and binding and should be read carefully.

1. This contract requires that Compliments and the Organization to comply with all state and federal laws in conjunction with any of the activities associated with this contract.
2. Compliments and the Organization hereby agree that no partnership or affiliation exists between the parties and that no officer of either party is employed by the other party.
3. This contract permits the person designated as Contact Person on page one or officers of the Organization to have reasonable access to Compliments':
  - a. financial records pertaining to the fundraising efforts defined in this contract.
  - b. operations, including without limitation the right to be present during any telephone solicitation.
  - c. employees or staff who are conducting fundraising or charitable solicitations on its behalf.
4. Compliments is a For-Profit corporation and receives the balance of the Sales price minus 25% as compensation for each card sold. Compliments will not represent itself as a non-profit organization.
5. There is no limitation to the minimum or maximum number of cards than can be sold by the Organization.
6. The Organization is responsible for all costs associated with marketing and selling the Compliments card, including, but not limited to transportation, insurance, salaries, benefits and other overhead expenses.
7. Any contributions made by purchasers of the Compliments Card, exceeding the cost of the card shall be the responsibility of the Organization and such contributions will not benefit Compliments.
8. Compliments shall maintain all records associated with the fundraising effort described herein. The Organization may maintain its own set of records and is entitled to data collected for the fundraiser activity.
9. The Organization will provide graphics / logos that can be used on the Compliments website. The Organization hereby authorizes the use of said graphics for the term of this contract to be displayed by Compliments.
10. Compliments will create the appropriate accounts and links on [www.TheComplimentsCard.com](http://www.TheComplimentsCard.com). Compliments may also provide you with links and graphics that can be placed on the Organization's website and/or sent out via email.
11. Any purchases that are made by clicking on those links will count toward the fundraiser effort and Compliments will pay a commission. The sole source of click through data and tracking will be through the Compliments website. Commissions will only be paid if the buyer purchases the card during the session initiated through the click through, or if the client specifically selects the fundraiser on the website.
12. Compliments will pay commissions to the fundraisers on the 1st and the 15th of each month for the periods of the 11th through the 25th (of previous month) and for the 26th (of previous month) through the 10th, respectively.
13. Compliments International does not guarantee the results of the fundraising efforts.
14. Compliments agrees to provide and deliver The Compliments Card within 2 weeks of order completion.
15. The Organization agrees to not promote or market any other gift or discount card during the term of this agreement.

17. Cash back rewards depends on the store's policies for paying out Contributions. We provide you with either a flat-rate dollar amount or a percentage of the purchase price that the average purchase from the retailer in question generates for your designated organization in Cash Back Contributions. Some retailers pay Contributions on a tiered schedule depending on the product or service you purchase from them, so the exact amount your designated organization receives may differ from the Typical Cash Back Contribution amount posted on your web portal. 23. The Organization is responsible for all costs associated with marketing Compliments fundraising programs, including, but not limited to transportation, insurance, salaries, benefits and other overhead expenses.
24. All the information you provide to Compliments is secured with SSL encryption in transit and stored in a secured database. Your information will never be sold or provided to third-parties as outlined in the Compliments Privacy Policy. All transactions take place on the retailers' respective sites, so your credit card information is never provided to or stored on Compliments website.
